## Easy Bakers Corner – Chocolate Mint Cupcakes - makes 12

Cream 1/4 cup butter, softened with 3/4 cup granulated sugar until light and fluffy.

Melt 2 squares unsweetened chocolate in a small saucepan over very low heat. Beat melted chocolate into butter mixture.

Add 2 eggs, 3/4 tsp. Peppermint extract and 1/2 cup of chocolate milk. Beat until creamy.

Sift 1 1/2 cups all-purpose flour with 1 tsp. baking soda. Mix into butter and chocolate mixture until well blended. Stir in 2 Tbsp. of crushed peppermint candies.

Pour batter into cupcake pan lined with baking papers.

Bake at 350°F for 15 to 18 minutes, or until done.

Remove from pan. Let cool on a wire rack.

For frosting, beat together 1/2 cup of butter, 2 Tbsp. Chocolate milk, and 1 1/2 cups of powdered sugar until light and creamy. Spread frosting over cupcakes.

Sprinkle with crushed peppermint candies.

### *Handy Tips:*

1. **Reheat Pizza:** Heat up leftover pizza in a nonstick skillet on top of the stove, set heat to med-low and heat till warm. This keeps the crust crispy. No soggy micro pizza.
2. **Reheating refrigerated bread:** To warm biscuits, pancakes, or muffins that were refrigerated, place them in a microwave with a cup of water. The increased moisture will keep the food moist and help it reheat faster.

**Mini report from the "Youth and Elders Focus Group" which took place on March 28, 08 in Richmond, B.C.**

To whom it may concern,

It was truly an honor to sit and listen to the many youth who spoke during the forum. We must give these young people great and loud applause, they went to the forum very well prepared, and they had done their research on housing. Both for 'On Reserve and Off Reserve.'

The youth delegates were from as far away as Fort Nelson, Hartley Bay, Fort St. John, Prince Rupert, Prince George, Vancouver, Penticton, Langley, and Kamloops.

Elders were selected and invited to attend the forum, there were ten elders, each representing their territories. I was invited to attend by the B.C. Elders Council to represent this region as well as the Council.

During the opening comments, several elders did recall having their own homes built without any help from the banks etc. Members of their villages came forward and did offer to help with their neighbors in building a strong family dwelling. That was a norm back then, home building was a community effort. Unfortunately today that does not happen.

Youth brought forward discussions and were seeking solutions.

1: Low paying jobs and poverty is a significant barrier to adequate housing, many of our youth and our elders have to settle for substandard housing in poor and sometimes unsafe neighborhoods. Elders living on a fixed income on reserve also face great difficulty obtaining a house.

2: Many elders do not feel comfortable living in "senior homes" that they feel are too modern, the design being more to the European tastes, and often do not allow for traditional practices, practices such as that of their territories. Of course each nation has a different tradition that they feel should be included in the daily regimen.

The elders and youth feel that each nation should be consulted in the construction of their buildings. The decor of the elders' homes should have the local shrubs etc. and the indoor design such as the lounge area should reflect the territory of the people.

Elders feel isolated from their families, culture, traditions, and heritage, all which can lead to despondency, loss of hope, and illness in.

Senior housing is often very expensive and elders on fixed income cannot afford to live in these homes.

Housing--this is a major concern for the youth, for students, single parents, parents whose children have moved out and there is just the two left at home. Everyone said this needs to be corrected, and affordable housing is a must for our First Nations people.

There were concerns brought up of inadequate home care or assisted living options for elders, both on reserve and off reserve. Many elders need medical attention and there is not enough support for this in areas such as home care with workers who speak the language and understand the cultures and traditions of their elderly clients.

Housing ---this is a major issue with the youth; it is a very emotional topic, because it is such an integral part of people's lives. They feel housing should be empowering; people should feel good about where they live and where they come from. Their homes, it was said, should be a place of refuge...a safe place to go after the day is over.

For centuries past our native people have always held the home as the one safe place, our children learned life skills that enabled them to live and to survive in the safety of their homes but today the places some of us live in are not so ideal.

Traditionally, families came together to build houses as a community. There should be training provided by government to the communities so that more people learn the skills of how to build good housing, this would allow members to build their own homes which would instill a sense of pride and ownership.

**Strong suggestions put forward to the government:**

Elder Housing needs to be a priority.

Land needs to be more accessible so people can build and own their own homes.

Land needs to be added to Reserves so communities can grow.

Funding such as mortgages should be accessible to elders on fixed incomes.

(All these should be accessible to elders who wish to build or purchase their own homes.)

If ever the lending institutions of Canada see the benefits of supporting the elders in their endeavors of home-ownership it would truly be a day of great celebration.

Many elders living off reserve are feeling a deep desire to return to their birth place and live their last days in happiness in their home communities and everyone should strive to help make that happen for elders so that they achieve their dreams of being back home.

## **UBCIC Calls on BC to Fully Implement BC Representative for Children and Youth Recommendations**

**PRESS RELEASE FOR IMMEDIATE RELEASE April 16, 2008**

(Coast Salish Territory/Vancouver, BC) - The Union of BC Indian Chiefs is calling on the Ministry of Children and Family development to fully implement the recommendations made by the BC Representative for Children and Youth, Mary-Ellen Turpel-Lafond. The recommendations were made in a report entitled "Amanda, Savannah, Rowen and Serena: From Loss to Learning" released earlier on this morning before the Legislative Standing Committee in Victoria. The recommendations follow an in-depth independent investigation conducted by Turpel-Lafond into the deaths of four children in the North Region.

The Office of the BC Representative of Children and Youth is an independent officer of the BC Legislature, which was created as a result of the recommendation made by the Hon. Ted Hughes in his report "BC Children and Youth Review: An Independent Review of BC's Child Protection System" released on April 7, 2006, which outlined in 62 key recommendations on improvements to the child welfare system in British Columbia. The Union of BC Indian Chiefs has supported Mary-Ellen Turpel-Lafond's work since her appointment in November 2006.

The Union of BC Indian Chiefs has reviewed the 11 recommendations made by Turpel-Lafond and calls on the Ministry of Children and Family Development to demonstrate the same level of commitment to implement these recommendations as they committed to the recommendations of the Hughes' Report.

"We have achieved significant and historic agreements such as the New Relationship, the Transformative Change Accord and Memorandum of Understanding for Aboriginal Children. Any implementation MCFD plan must be in keeping with the spirit, intent and commitments of these historic agreements," said Chief Phillip. "We need to be full partners in the development of any and all plans with our communities' priorities at the forefront."

Grand Chief Stewart Phillip has further commented "We cannot afford to continue to look the other way as our communities are in crisis. With the barrage of youth suicide rates, combined with drug- and gang-related violence, it is more important than ever that we continue our focus on our children. We cannot afford to stand by silently as the child apprehensions occurring in our communities reach epidemic proportions".

The Union of BC Indian Chiefs has strived to work in conjunction with the Ministry of Children and Family Development towards the creation of Regional Aboriginal Authorities for the past five years. The full implementation of these 11 recommendations made by Turpel-Lafond would give a clear demonstration of on-going efforts by the Ministry of Children and Family Development to work with BC First Nations exercising their inherent right to the health and well-being of our children.

# Canada Continues Offensive Campaign Opposing UN Declaration on the Rights of Indigenous Peoples

News Release FOR IMMEDIATE RELEASE April 17, 2008



Coast Salish Territory/Vancouver - In a statement delivered to a meeting of the Organization of American States Working Group to Prepare the Draft American Declaration on the Rights of Indigenous Peoples ("OAS Working Group") in Washington DC, the Canadian Government has declared that it will no longer actively participate in negotiations on the Draft American Declaration on the Rights of Indigenous Peoples ("Draft American Declaration").

Canada has formally reserved its position on the final text under negotiation. However, if the final document "does not adequately address Canada's concerns", Canada has indicated that it would attempt to block consensus unless two conditions are met: the document adopted clearly indicates that Canada does not support it and that there is an explicit understanding that the text therefore does not apply to Canada.

In doing so, Canada has continued its offensive campaign against the rights of Indigenous people in Canada and around the world by maintaining its rejection of the United Nations Declaration on the Rights of Indigenous Peoples ("United Nations Declaration") as the "starting point or minimum outcome for further negotiations" on the Draft American Declaration.

"In its statement to the OAS Working Group, the minority Conservative government has again demonstrated immense disrespect for the human rights of indigenous peoples", said Grand Chief Edward John of the First Nations Summit political executive. "Canada's attempts to "pick and choose" which human rights standards apply to it violate the rule of law in Canada and threaten the international human rights system. We urge the Canadian government to play a constructive role in deliberations on the Draft American Declaration, to drop its unreasonable conditions and to not block consensus on the final text."

The United Nations General Assembly overwhelmingly adopted the United Nations Declaration on September 13, 2007. Canada was one of only four States to vote against the United Nations Declaration.

The rights recognized by the United Nations Declaration constitute the "minimum standards for the survival, dignity and well-being of the indigenous peoples of the world". The majority of American States have supported the use of the United Nations Declaration as the baseline for negotiations on the Draft American Declaration.

Canada's statement to the OAS Working Group directly defies the motion passed by a majority of Parliamentarians in the House of Commons on April 8, 2008 calling upon the Government of

Canada to endorse the United Nations Declaration, and for Parliament and the Government of Canada to "fully implement the standards contained therein".

"OAS member states have a duty to ensure the minimum standards set out in the United Nations Declaration are upheld in the draft American Declaration" stated A-in-chut (Shawn Atleo), Regional Chief of the BC Assembly of First Nations. "BC First Nations urge the Government of Canada to continue working with OAS member states and indigenous peoples to build on the important foundation of international human rights standards set out in the historic United Nations Declaration. Let us work together to leave a legacy for future generations that we can all be proud of."

"Canada, under the leadership of Prime Minister Stephen Harper continues to wantonly exploit the lands and resources of the indigenous peoples of this country. It is despicable to witness the lengths governments and companies have gone to use Canadian courts to jail Indigenous people for protecting their territories," said Grand Chief Stewart Phillip, President of the Union of BC Indian Chiefs. "We call on the entire international community to witness that Canada has prosecuted and imposed jail terms on indigenous leaders of the Agonquin Ardoch and Kitchenuhmaykoosib Inninuwug First Nations for their efforts to protect the birthright of their children and human rights of their peoples. Once again, at the international level, Canada has disgraced itself by demonstrating its racist and highly prejudicial attitudes towards the land and human rights of Indigenous Peoples here in Canada and throughout the world."

## **Bill 15 to enrich private power producers, shock ratepayers and harm the environment says Wilderness Committee**

Vancouver, BC ~ The Wilderness Committee today sounded the alarm about legislation rapidly moving towards becoming BC law. Bill 15, the Utilities Commission Amendment Act, is waiting for Royal Assent in the BC Legislature, before becoming law.

Two years ago the government of BC passed Bill 30, which removes local community government oversight of private power projects. Now Bill 15 aims to significantly reduce the oversight of the BC Utilities Commission over private power projects. Bill 15 will largely strip the Utilities Commission of its independence and make it impossible to stop bad deals without the consent of the provincial government.

Currently, the BC Utilities Commission has the authority to order a stop to agreements made by the BC Government to purchase power from private producers if those agreements have prices set so high they are a bad deal for provincial ratepayers. Formerly the BCUC was tasked with protecting the best interests of British Columbians in regards to power purchases by BC Hydro.

“The result of this proposed law will come back to shock anyone who pays an electrical bill in this province,” said Joe Foy, Wilderness Committee Campaign Director. “Many of these proposed projects would not be possible, if not for the inflated rates that Bill 15 will facilitate. With the passage of Bill 15 the Utilities Commission becomes nothing but a toothless lap dog on a choke chain catering to the private power producers’ every desire.”

The Wilderness Committee believes that Bill 15 has been introduced because of the gold rush of private power developers currently staking hundreds of rivers and streams across the province. “The BC Government doesn’t want to be embarrassed by the Commission telling the public that these private developers are being paid too much for their power,” said Gwen Barlee, Policy Director with the Wilderness Committee. “This Bill greases the skids for private power developers and leaves the public out in the cold.”

“As a result of Bill 15, we are going to see environmental degradation in streams where private power projects should never have been built and we’ll see our power bills go through the roof,” commented Foy.

The Wilderness Committee opposes the passage of Bill 15, is calling for the repeal of Bill 30 and supports an immediate moratorium on private hydropower development in BC.

**Sea lice spread to British Columbia's most lucrative fish stocks**  
*Campbell River Salmon and Herring worth nearly \$80 million to province last year*

**Echo Bay, British Columbia, March 31, 2008** - The latest scientific paper on sea lice reports that infestations have spread to juvenile pink, chum, and sockeye salmon as well as juvenile herring near Campbell River fish farms. The study was published online by the North American Journal of Fisheries Management.

The Campbell River area is known as the Salmon Capital of the World, and accounts for a large portion of the \$233 million a year in sport fishing tourism that the British Columbian government collects.

Alexandra Morton R.P.Bio. (Salmon Coast Field Station), Dr. Richard Routledge (Simon Fraser University) and Dr. Martin Krkosek (University of Alberta) looked at 4,700 young wild salmon near and distant to fish farms in 2005 and 2006 throughout the Discovery Islands.

“We found four times as many wild juvenile salmon were infected with sea lice near fish farms than distant from the farms,” says Alexandra Morton. “Then in 2006 when most of the farms were empty, the sea lice declined”.

“This is the same pattern we see in the Broughton Archipelago,” added Dr. Routledge, “Where there are farm fish the young wild salmon are infested with lice. Remove the farm fish and the sea lice problem disappears.”

The study looked at other variables, including salinity and temperature, but found that farm fish were the only significant factor contributing to the infestations.

The study was made possible through the dedication of several commercial fishermen who did the sampling.

Pink and chum salmon were the primary study focus, but juvenile herring were also examined and found infested with lice. The herring were tiny and still lacking scales suggesting high vulnerability. This is the first report of sea lice on herring this young.

In addition, juvenile sockeye were discovered to be infested near the farms. Last summer, commercial salmon fishing was closed on the south coast because so many of the Fraser River sockeye failed to come home. Some of the sockeye that went “missing” last year were likely infested with sea lice in 2005 when they migrated to sea.

“We did not test the DNA of the sockeye we examined,” explains Dr. Martin Krkosek. “However, we know that many Fraser River sockeye migrate through our study area.”

The report concludes there is urgent need to implement policy that protects wild salmon from farm fish.

Currently Minister Pat Bell has called for more drug use to control lice. But Morton disagrees, saying that using drugs creates concerns for environmental and human health. The drug (Slice) has not been approved for use by Health Canada and may impact important stocks of crab, shrimp, and prawns.

Morton concluded: “The only measure that is going to work is separating the farm and wild salmon. This can only be achieved by completely closed containment technology or moving the farms. If nothing is done now, I worry that Canadian salmon stocks will suffer the same fate as European salmon stocks that have declined dramatically in fish farming regions.

## **K'ómoks First Nation and Sage Hills Developments sign Memorandum of Understanding**

**COURTENAY, BC (March 26, 2008)** – The Sage Hills project, a 2,083-acre sustainable living community proposed for the Comox Valley took another step forward with the historic signing of a Memorandum of Understanding between the K'ómoks First Nation and Vancouver Island-based Sage Hills Developments (SHD). Technical studies are already underway and the formal rezoning, community involvement and entitlement processes will begin in April.

For millennia, the K'ómoks First Nation has lived in a territory that stretches from Kelsey Bay south to Parksville and includes Hornby and Denman Islands. Sage Hills Developments Ltd. is a wholly owned subsidiary of Vancouver Island-based IAC-Independent Academies Canada Inc. and is the vision of SHD Chairman Ted Everett.

The Sage Hills project will contribute in a very substantial way to the living and learning environment of the region. It will include the development of a university and associated facilities, a K-12 school, wellness facilities and health programs, corporate retreat, golf courses, a university village center and sport training facilities to be managed by IMG.A.

The community will endeavor to minimize the impact on the environment by being planned around "Green Principles" that will meet or exceed the sustainable guidelines the Provincial Government is aspiring to meet. On hand to sign the MOU on behalf of the K'ómoks First Nation were Chief Ernie Hardy, Councillor Stewart Hardy and Councillor Barb Mitchell.

"We want to acknowledge the respectful approach that Sage Hills has taken in recognizing our nation's historical relationship with these lands," said Chief Ernie Hardy. "The K'ómoks Nation will benefit economically, socially and culturally from the beginning of the project and into the future because of educational, cultural and business arrangements that will be developed with Sage Hills."

### **Education**

Sage Hills has negotiated an agreement with LearningWise International Inc. (LINC) to operate the main campus of University Canada West and a kindergarten-to-grade-12 private school at Sage Hills, along with other educational programs and facilities as they develop. Sage Hills and UCW will create state-of-the-art private educational facilities that reflect a global perspective combined with a dedication to social diversity and advanced learning. The goal is to cultivate confident, knowledgeable and caring leaders who have the ability to embrace a sense of purpose and understanding.

### **Sports**

Sage Hills has negotiated a partnership with IMG Academies (IMGA) of Bradenton, Florida to provide planning input and brand management for an IMG Academies at Sage Hills. This academy will be the first of its kind in Canada and the third in the world.

We envision an IMG Academy that will integrate junior, collegiate, adult/corporate and professional athletic and leadership programs to give athletes the tools to compete at the highest levels and excel under the pressures of competition. The sports offerings under consideration will include hockey, skating, golf, soccer, baseball, basketball and mountain sports.

### **Sustainable Community**

The physical heart of the Sage Hills community is envisioned to be a village commons where education, sports, wellness, events, and a hotel will be located. The center will incorporate village-style streetscapes, pedestrian-friendly roadways and tree-lined avenues. There will be vehicle-free areas within the village, and walking and bicycle paths. Through research, demonstration projects, leadership and innovation, the overarching design philosophy will bridge today's knowledge of sustainable living and future possibilities.

Lifestyle, real estate and community partnerships round out the key components of the sustainable theme. The fundamentals of sustainability require that the entire human experience be addressed in a sustainable way – from how we recreate to how we live in our homes.
